S.V. Eureka processes your personal data because you use our services and/or because you provide these data to us yourself. Below you will find an overview of the personal data we process:

- First and last name (for e.g. registration activity)
- Date of birth (for e.g. trip abroad)
- Address details (for e.g. ordering merch)
- Telephone number (for e.g. contacting for an activity)
- E-mail address (for e.g. sending the newsletter)
- Bank account number (for e.g. financial administration)

Special and/or sensitive personal data we process

S.V. Eureka processes the following special and/or sensitive personal data about you:

- health (mainly for travel)
- passport number (mainly for the trip)

For what purpose and on which basis we process personal data

S.V. Eureka processes your personal data for the following purposes: - Handling your payment

- Sending our newsletter and/or promotions for events
- Calling or emailing you if necessary to carry out our services

Automated decision-making

S.V. Eureka takes responsibility on the basis of automated processing decisions about matters that could (significantly) affect individuals.

These are decisions made by computer programmes or systems, without any human being (e.g. an employee of S.V.

Eureka) is involved. S.V. Eureka uses the following computer programmes or systems: -Google Drive.

How long we keep personal data

S.V. Eureka will not keep your personal data longer than strictly necessary to realise the purposes for which your data are collected. We apply the

following retention periods for the following (categories) of personal data: -Sensitive personal data: until one day after the data is no longer needed. -Regular personal data: at the latest until the end of the university block in which the data is needed. Sharing

personal data with third parties

S.V. Eureka does not sell your data to third parties and will only provide them if this is necessary for the execution of our agreement with you or to comply with a legal obligation. With companies that process your data on our behalf, we conclude a processor's agreement to ensure the same level of security and confidentiality of your data. S.V. Eureka remains responsible for this processing.

Cookies, or similar techniques, that we use

S.V. Eureka does not use cookies or similar techniques.

Data inspection, modification or removal

You have the right to view, correct or delete your personal data. In addition, you have the right to withdraw your possible consent for the data processing or to object to the processing of your personal data by S.V. Eureka and you have the right to data portability. This means that you can submit a request to us to transfer the personal data that we hold about you in a computer file to you or another organization named by you. You can submit a request to inspect, correct, delete or transfer your personal data at S.V. Eureka. The request is made via email.

personal data or request to withdraw your consent or object to the processing of your personal data to bestuur@sveureka.nl. To ensure that the request for inspection is made by you, depending on whether the board knows how the applicant looks like, we ask you to send a copy of your proof of identity with the request. In this copy your passport photo, MRZ (machine readable zone, the strip of numbers at the bottom of the passport), passport number and Citizen Service Number (BSN) in black. This is to protection of your privacy. We will respond to your request as soon as possible, but within four weeks. S.V. Eureka would also like to inform you that you have the option of submitting a complaint to the national supervisory authority, the Authority for Personal Data. You can do so via the following link:
